Becky has been a League member for many years and has represented the League when our positions on natural gas fracking, air pollution and organic farming have needed local representation. On Thursday, May 20th, the <u>Pennsylvania Solar Center</u> recognized the <u>Kretschmann Farm</u> with its **Lodestar Agrivoltaic Award**.

The Agrivoltaic Award recognizes a farm that replaces its use of fossil fuels with solar power. Their organic farm, located in Rochester, PA installed solar panels in a section of the farm that was not suitable for crops and generated more electricity than it needed for the farm.



The elimination of electric bills and the sale of the extra power paid for this system in four years. Don Kretschmann said that he likes the economic benefit, but he is much more concerned about doing everything he can to reduce the impact of climate change. **Congratulations to Becky and Don!**



VOTER SERVICE by Judy Clack, Voter Service Chair

College/University Committee Report, Cynthia Cominsky

From the January 6 Capitol insurrection until the Primary Election, messages (Teasers) were sent to all area campuses with links to voter and civic education information. Teasers are short summaries that could be easily sent out to campus networks via social media. The College/University committee is now making plans for how best to provide election information for the fall.



The College/University Committee is looking for **two more volunteers** to serve as liaisons with these academic institutions: **University of Pittsburgh** and **Westmoreland County Community College**. A list of developed contacts would be shared. Each committee member emails LWVPGH voter education documents and teasers to each campus. On May 12, members of the committee met with PA representatives of the ALL IN Campus Democracy Challenge. The goal of the meeting is to learn about components of the ALL IN Campus Democracy Challenge and the requirements of participating colleges/universities. Several of the schools we support participate in the challenge. We will take what we learn in the meeting to determine what we have that can assist our schools in participating in the challenge. The All IN Campus Democracy Challenge is a nonpartisan, national program that rewards schools for registering, engaging, and educating students. At this time, helping schools participate in the ALL IN Campus Democracy Challenge, means sharing LWVPGH resources (infographics, education, and registration events, etc.); many of these resources already exist.

Food Pantry Committee Report, Kathy Herbst

A group of LWVPGH members worked on distributing 5,000 rack cards to 140 food pantries in Allegheny County. The heavy-weight cards contained information on the primary election including dates, deadlines, closed primary definition, and the existence of ballot questions on which everyone could vote. We met and prepared the packets for distribution. The pantries were selected based on information and contacts by the Junior League, who initiated this outreach along with the LWVPGH in 2020. Members reported varying degrees of success in contacting food pantry staff. Last year most distribution was done through the Food Bank, with some in-person drop off, and some mailing.

The committee will begin meeting monthly, on the **fourth Tuesday of the month**, beginning on <u>June 22</u>, from 11:30 to 1:00 pm. A Zoom invitation will be sent to everyone who participated during the latest distribution. Please send an email to **Kathy Herbst** (<u>kmherbst0917@verzon.net</u>) if you are interested in helping future food pantry voter education outreach. The group will develop a timeline and work plan to be used for the fall election.

Naturalization Committee Report, Judy Diorio

Although LWVPGH members have been unable to participate in person at Naturalization Ceremonies since March 2020, our League has continued to provide information to new citizens. The administrators at both sites, USCIS Penn Center and US Federal Courthouse Pittsburgh, have distributed LWVPGH information at the end of the very small ceremonies where only the candidates can attend. We provided our Facts for Citizens (both 2020 and 2021 editions) and line-by-line instructions on how to complete a voter registration form. In addition, we created, printed and distributed a new two-sided flyer containing information about the PA May 2021 primary election.

From June 2020 – May 2021, 1, 776 new citizens received voter education information from our League. As soon as volunteers are allowed to register voters at naturalization ceremonies, LWVPGH members who are fully vaccinated will be recruited. Public Access TV Committee Report, Jane Butler

A new endeavor by the LWVPGH is providing content to public access TV stations. We have several very engaged partners at public access TV stations who have broadcast all the statewide judicial forums (cosponsored by LWVPA) and a few short LWV videos. The programs aired up until the May 18th primary. Jared Robinson of Monroeville, Glenn Ward of Upper St. Clair, Ron Bandes of PCTV21 and Nick Shalles of Mt. Lebanon have enthusiastically participated in this effort for the primary.

We will be evaluating this program after the election to see how it worked and what more we can do. Providing short LWV educational videos would be welcome. **Eileen Olmsted** asked if there is a way a way to publicize Vote411.org on this platform. **Amy Kleissas** volunteered to help us in the effort to make a video about Vote411 before the General Election. **We need more members** who could develop the content and others with video creation experience. Senior Subsidized Housing Committee Report, Jane Butler

The committee designed and had printed 2,500 door hangers to distribute with basic voting information about the Primary election. It was created in a bigger font that was requested from our senior survey after the November election. Each committee member called certain buildings who had done significant outreach in the fall. We asked if the manager would agree to put these door hangers on residents' apartment doors. **Linda Schneider** spear-headed this effort. There were 600 door hangers left. Since their information was timesensitive, they found a home, again thanks to the outreach of **Linda Schneider**.

Kathy Herbst was in charge of our first in-person voter registration and change of address event since the pandemic started in March 2020. Two Leaguers, **Kathy Croft** and **Sue Ellen Ganz**, assisted the manager at Midtown Towers, a newly renovated senior housing building downtown whose residents had recently relocated there. Fifteen residents were able to register, do address changes, or apply for a mail-in ballot.

Jane Butler recorded a 90 second voting message about our partnership with PCTV21 (the Pittsburgh city public access to channel): how to access the channels, YouTube, LWVPGH.org, Vote411 and the importance of voting in this Primary election. This message was broadcast by our contact for the Housing Authority of the City of Pittsburgh and were aired to all employees and residents on Fridays until the election. More LWVPGH members are needed to continue our expanding outreach to seniors in subsidized housing in the county. If you'd like to join us, please contact Jane Butler: jbutler.mac@mac.com.

Vote411 Report, Annette Shimer

For our May 2021 municipal primary Vote411.org voters guide, we included **1,181 candidates in 22 race** categories from **140** municipalities, **40** school districts, and **21** magisterial districts as well as the state-wide judicial races and all the statewide and local ballot questions. New this year were the GIS files for magisterial races. Elected official job descriptions were defined and/or refined. 172 candidates were invited to participate (that is, those candidates for whom an email address was found), 114 candidates responded (66%). Due to the number of Court of Common Pleas candidates (39), the price for our printed Voters Guide jumped to \$4,200. At 32 pages this was the largest we have ever printed. In the fall, the cost was \$3,000 for the 24-page guide.

Coming up next includes carefully cleaning out the losers remembering that there will be a number of third-party candidates appearing, some will change party, and more two-year terms races will be created. The LWVPGH must do an analysis of the races to determine potential candidate forums: some school board races

have two slates of candidates in the fall as well as 15 Common Pleas candidates for nine seats. We will need LWVPGH member help to obtain more email addresses and encourage more candidate participation in Vote411 for the fall General Election. Primary Candidate Forums Report, Judy Clack

For the 2021 Primary, the LWVPGH organized or partnered in **ten** virtual candidate forums. We co-sponsored most with local non-partisan organizations, some of which took over the Zoom duties since they had a Webinar account or were TV stations. Recordings of all candidate forums, sponsored or co-sponsored by LWVPGH as well as the three LWVPA statewide judicial forums, were available at http://lwvpgh.org/forums. THE LWVPGH WEBSITE AND SOCIAL MEDIA ACCOUNTS TEAM UP FOR THE PRIMARY by Emily Ferri & Ruth Quint

In the month leading up to the May primary, LWVPGH reached thousands of area voters with voter service information through our website and social media platforms. The web team produced several new pages focused on the primary and used them to promote information in several formats ranging from the League's long-running Candidate Forums, Vote411 and Voter's Guide, to innovative formats like the Common Pleas Video Gallery and infographics on high-interest topics, like the ballot questions, and mail-in voting. Likewise, LWVPGH Facebook, Twitter, Instagram, and YouTube social media accounts shared infographics, articles, videos, and links (especially to the new resource pages on our own website) to help reach a greater audience.

Social Media and the Website

The new Club Express software makes it easy to include content from our social media on the website. The Twitter feed is always featured on the homepage, and videos housed on our YouTube or Facebook accounts can be embedded in a webpage. This serves to introduce new users to the social media accounts.

The social media accounts in return, advertise new events, infographics and forums, and point new users to the website. When users like, share, or comment on a LWVPGH social media post, their own friends and followers may then in turn see that interaction on their own pages, exposing users that may not be familiar with LWV to our information and resources. By pointing users to additional information from social media pages to the website, and vice-versa, the two processes form a "virtuous circle" of awareness about LWVPGH.

For example, now that voters are able to find the LWVPGH YouTube channel easily from the website, there has been a large increase in video views leading up to the election. In the past 28 days, there were 7,600 views on the YouTube channel – previously, there were usually only 10-50 views per month!

"Classic" LWVPGH Voter Services extend their reach online

During primary season, the social media and the website expanded the audience for the League's long-running voter service programs. For instance, this year LWVPGH organized or cosponsored 12 candidate forums, all of which were held online and live streamed on Facebook or YouTube. After each event, the recording was posted online, in some cases on our own social media platforms, and sometimes on the website of a co-sponsor. The Candidate Forums page allowed us to gather all of the videos in one place and made it easy for people to find them. During primary season, the Candidate Forums page received over 1200 views. Top forum video views on hosted on LWVPGH Facebook and YouTube were the Pittsburgh Public School Board (over 2,200 views), Magisterial District 05-02-04 (over 1,100 views), Magisterial District 05-02-19 (over 1,100 views), and Pittsburgh City Council (800 views).

The Voters Guide, which is printed in the New Pittsburgh Courier every election season, was posted on the homepage and Primary 101 page about a week before Election Day and was downloaded 775 times. Vote411 was featured on every primary page, and while it's impossible to tell how many people "clicked through," it's probably safe to say that 100s of people came to the website looking for Vote411 and used this service.

New digital formats

Some of the popular primary resources on the website were in formats that are new to LWVPGH since last year. The Candidate Forums team was determined to provide a forum for the 39 Court of Common Pleas candidates and came up with the idea for the Common Pleas Video Gallery, which posted a short video statement from each of the 33 candidates who participated. The page was viewed over 2,600 times, with over 6,700 combined individual video views.

Infographics created for the primary received hundreds of downloads, including almost 500 downloads of a graphic about the "Permanent List" for mail-in ballots, almost 400 downloads of a graphic about the importance of Municipal Elections, and over 1,500 downloads of an infographic about the PA Ballot Questions. This is in addition to the circulation of these documents on Facebook and through newsletters, and circulation by other Pennsylvania local leagues and community organizations.

Infographics were also some of the most popular posts on our Facebook page during this time as well. The graphic announcement of the Court of Common Pleas video gallery had a post reach of over 3,200, an explanation of PA amendment ballot questions with a reach of 2,000, a schedule of upcoming election deadlines with a reach of 1,800, and an explanation of Vote411 with a reach of 1,200.

- 85 new followers

COUNTER POLITICAL POLARIZATION THROUGH BRAVER ANGELS WORKSHOPS

The LWVPGH with multiple other community hosts are co-sponsoring a series of **Braver Angels Workshops** to help area residents mend the political divide by teaching communication skills in a series of free workshops over Zoom from June through November 2021. Braver Angels is a non-partisan, national organization run by volunteers which offers these workshops free of charge. Participants can sign up for one or more of these workshops. Each is a stand-alone experience and may be repeated. One workshop was given locally on Zoom on April 19. Over 120 registered and over 80 participated. Here's a full description of the series and then of the individual workshops.

Our country has become increasingly polarized over political issues. These free workshops will teach you strategies for both listening and speaking with people who have differing political opinions — without trying to change anyone's mind. You will learn and practice skills for having respectful conversations that clarify differences, search for common ground, and affirm the importance of meaningful dialogue. Marvelous Members The Wise Women (and Men) of the League

With the whirlwind of Primary 2021 behind us, I wanted to interview Judy Clack, Voter Service Director and driving force behind the LWVPGH's Candidate Forums. See her personal, inspiring story below.

Amy Kleissas

1. Describe your early years; where you were born, family then and now.

I was born in Montgomery, Alabama, my mother's hometown, during WWII. We moved to Oakridge, Tennessee where my dad worked on the Manhattan Project building the atomic bomb. We moved north after the war to New Jersey and New York where my dad was a chemical engineer. I spent most of my life in a small town in the Finger Lakes region, Bath, New York, with two brothers and a stayat-home mom. I was valedictorian of a small high school with 110 in graduating class.

I was married for 13 years, had two sons, Bill and Steve, and then divorced. Next came the working, single-parent gig. Thanks to couples' therapy after the divorce, we were able to congenially attend all band concerts, soccer games, wrestling and swim meets side-by-side. I'm proud of that.

I resigned from my job at Elmira College, Elmira, New York in 1999 and moved to Austin, Texas to care for my dad. After his death in 2015, I moved to Gibsonia, Pennsylvania to help my son, Bill, with his two children.

2. Tell us about your educational background; who was your favorite teacher and why or who inspired you? BA, Mathematics, SUNY Buffalo; MS Ed, Mathematics, SUC Buffalo; MS Ed, Psychology, Elmira College. *Favorite teachers:* elementary school, 3rd grade, Miss Kolpien; 5th grade, Mrs. Spraker. I decided I wanted to be a teacher when I was in elementary school and never changed my mind.

3. What is your professional or work history?

For six years I taught high school mathematics in New York and in Vermont. I spent 27 years as a graduate school administrator at Elmira College, Elmira, New York and at the University of Texas at Austin.

4. Why and when did the League become important to you?

In 1976, I was interested in recycling and joined the LWV of Chemung County in Elmira, NY. I was going through a rough time in my marriage. The LWV provided reading materials to study and tasks to do, and both helped rebuild my self-worth. I was "volunteered" almost immediately to be recycling chair and within a year, president. In my first year as president, our League won a state award for the largest percentage of membership increase. When I left after three years as president to go back to work full time, I wrote in the *Voter; "The League and I had a symbiotic relationship -- I nurtured the League and the League nurtured me."* The League had saved me emotionally. I re-learned through the League that I could read, write, lead, inspire. The League (and therapy) rebuilt my self-esteem. The League also helped me get a full-time job when my interviewer at Elmira College gave me "credit" for my years of volunteering and the skills I had gained.

5. What was/is your League "portfolio", including offices you held?

LWV Chemung County, Elmira, NY: Recycling Chair, President, Treasurer LWV Austin Area, TX: VP Organization; Voter Editor LWV Greater Pittsburgh, PA: Voter Service Director

6. What do you feel is the most important things you accomplished or are accomplishing for the League and for our democracy?

I am so proud of the multiple voter service subcommittees that were established during the pandemic that increased the LWVPGH's outreach in the community beyond what we had been doing in person. Some members accepted the challenge (voluntarily or after being volunteered) of being committee chairs. Many other members joined one or more committees and followed through by attending virtual meetings, planning actions, and spending hours on tasks adopted by that committee. The LWVPGH reached thousands more voters in our county than ever before.

7. What are your concerns and/or hopes for a post-pandemic America?

I am most concerned about the laws that reduce the access to the ballot or to the polls that are being proposed in almost every state in our country. The League of Women Voters must fight against disenfranchisement of any eligible voter whether in Allegheny County, the State of Pennsylvania, or any other state in the union.

8. What are your wise words for the rest of us?

Every person has worth, has value, has something to contribute. Recognize each person's contribution. Include all who want to volunteer.

"Life" happens to volunteers and interrupts their service. Be supportive when a member must step away for a while. The LWV will be there for them to return to when they are able to do so.

- A Fighting Chance by Elizabeth Warren
- Breaking Hate by Christian Picciolini
